 - -#1 We like the "welcome to altadena" sign:
 - --texture of rocks
 - --theme of city is displayed with foothills, tree, stone
 - -- the 3D aspect
 - --tree silhouette
 - --We like the Stigler sign- the molded/etched stone.
 - --#2 what beautiful things come to mind about valley Glen?
 - --diversity (most diverse in all of LA)
 - --community
 - -#3 elements special to Valley Glen? California palm tree, LA river haron bird, LA River
 - -#6 logos that need to be on the sign? Just our neighborhood council logo
 - -#7 additional notes? Lighting- we'll see about LEDs, battery operated or solar power lighting
 - --We'll look into the possibility of fundraising with LA Metro, Valley College, LAUSD.
 - --Elements we have to have on the sign:
 - --our greater valley Glen logo (I'll give you the hires file)
 - --smaller text Greater Valley Glen Neighborhood Council (we might leave 'neighborhood' out though)
 - --big text Valley Glen (we might want 'Welcome to' added but maybe it's too much)
 - --City of LA logo? Maybe, maybe not





Once we have our chosen comp picked out, Julie will contact the sign fabrication companies and get rough quotes & info on how to proceed.
