- 2. Roll Call Julie, Sloan, Joseph, James, Mickey; Joanne & Walter from the public (GVGC board members)
- **3.** Approve February 19, 2019 Minutes- Motion 2<sup>nd</sup> by Sloan. Vote: 5 yes- Julie, Sloan, Joseph, James, Mickey; 0 no. Motion passes.
- **4.** Review the 2<sup>nd</sup> round of design options for the "Welcome to the neighborhood" monuments & choose the final design.
  - Committee Member Comments: We like the first design the best (see attached photos on next page) because of it's brightness and contract between the background and the text. We would like to include the 2<sup>nd</sup> & 3<sup>rd</sup> as options depending on what the fabrication company says on how we can show texture while keeping it graffiti proof.
  - Public Comment: Walter (also a board member) came to the meeting to disagree with the text on the sign. He
    believes it should say "Greater Valley Glen" not just "Valley Glen" because the border of Valley Glen is 1 block
    north of the sign & 1 block west. The committee members disagreed with adding "Greater" because Greater
    Valley Glen is just a distinction for the neighborhood councils and is not actually a location.
  - **MOTION 1:** The Arts Committee requests the Board approve the final design concepts (attached on the 2<sup>nd</sup> page), with priority given to the 1<sup>st</sup> design, for the "Welcome to the Neighborhood" monuments to move forward with and start fabrication. Motion 2<sup>nd</sup> by Sloan. . Vote: 5 yes- Julie, Sloan, Joseph, James, Mickey; 0 no. Motion passes.
- **5.** Review bids from sign fabrication companies to create the "Welcome to the neighborhood" monuments & possibly choose one to move forward with.
  - We reviewed 3 bids for the fabrication of the monuments. One was the lowest cost, however, with demolition added it would probably be the same as another bid. The 2<sup>nd</sup> bid is the company we agreed upon to hire because an employee from the company met with Julie and thoroughly went through what was included in the cost and was willing to work within our budget. The 3<sup>rd</sup> bid was way over budget.
  - With the bid from the company we will hire, we lowered the cost by agreeing to have their company name on the back of the monument, using the same foundation the current monuments are on, and that we won't incur permit costs.
  - MOTION 2: The Arts Committee requests that the Board approve up to \$15,000 to fabricate & install one "Welcome to the Neighborhood" monument. Motion 2<sup>nd</sup> by Sloan. . Vote: 5 yes- Julie, Sloan, Joseph, James, Mickey; 0 no. Motion passes.
