Motion stating that the Greater Valley Glen Council supports the Budget Advocate's letter dated 11/10/2014 (see Addendum A) and the Board of Neighborhood Commissioners (BONC) letter dated 11/12/2014, requesting 7 new Exempt or Emergency Appointment positions be allocate to DONE. DONE is severely under staffed with only 1 Supervisor and 5 field staff to cover and support 95 neighborhood councils and has experienced a 70% cut in staff Since 2004. (Council File 14-0600-S142.

<u>Proposed Community Impact Statement:</u> Council File 14-0600-S142 – The Greater Valley Glen Council supports 7 new Exempt or Emergency Appointment positions be allocated to the Department of Neighborhood Empowerment (DONE). DONE has experienced a 70% cut in staff since 2004 and has reached the point where it may not be able to fulfill its Charter mandated responsibilities to foster and support Neighborhood Councils.
