The Greater Valley Glen Neighborhood Council requests that the developer work to ensure that adequate traffic calming measures, consistent with the size and scope of the final project, be identified and implemented. As Laurel Plaza's neighbors to the north and to the east are primarily single-family homes, any structures to be built along Erwin Street and Radford Avenue should not exceed 45 feet in height in order to minimize their impact on the existing ambience of the adjoining neighborhood and in accordance with the North Hollywood --Valley Village Community Plan. W. Hall moved and C. Ferreyra seconded. Motion passed unanimously. C. Ferreyra to write letter by Sept. 22, 2016 to Developer.

- b. Motion for Board approval approving payment to the LA Corp of Conservation of \$2500 (in monthly payments) to provide bi-monthly (2X/month) supplemental watering to 35 park trees within Valley Glen Community Park. Watering can be stopped at any time, without Penalty. S. Myrick moved and R. Pisani seconded. Motion passed. (12 yes, 2 absent, 1 ineligible).
