### Planning and Land Use - Doug Breidenbach, Chair -

No motions submitted. Reported that Chipotle has applied for a full liquor license for indoor service only at proposed Victory Plaza location.

Outreach and Safety Committee— J. Chadwick, Chair.

Committee report: No quorum at committee meeting. Banners to be approved. Adding Facebook page. New website proof to be presented to Board and info sent to DONE. Problems with Aaron DeVandry having moved our website to his server. Carlos has not been able to update our calendar.

### Government Relations - W. Hall. Chair

a. Motion for Board approval of a letter stating that the Ordinance No. 184526 adding Section 22.819 to the Los Angeles Administrative Code establishing a procedure for stakeholders to create a certified Neighborhood Council within the boundaries of one or more existing certified Neighborhood Councils is deficient and is in need of amendment. With respect to neighborhood council subdivision as created by this ordinance, review and approval of procedures, rules and regulations made by the Department of Neighborhood Empowerment (DONE) and decisions made in accordance with those procedures, rules and regulations should be subject to approval by and /or appeal to the Bureau of Neighborhood Councils. Presently, procedures and rules now in place as promulgated by DONE are in variance with the regulations for neighborhood council creation as set forth in Ordinance No.176704. Additionally, neighborhood councils affected by a proposed subdivision should be duly notified of such subdivision submittal but remain neutral in the process prior to the election determining approval of the proposed subdivision. Furthermore, subdivision submittals accepted by DONE but found to be deficient shall remain in effect with the submitting entity given the opportunity to correct any deficiencies necessary to meet subdivision requirements as needed to move on to the election stage. Committee Chair and Council President to determine recipients of the letter.





W. Hall moved and C. Ferreyra seconded. Motion passed unanimously.

**b. Motion for Board approval** of the C.I.S. stated below supporting the Code Amendment per Council File Number 13-1339 to add the toyon, the official plant of the City of Los Angeles, and the Mexican Elderberry to the City's list of Protected Trees. Additionally, should there be cause to remove any protected tree, the toyon or Mexican Elderberry shall not be used as substitutions for any other type of protected tree. (Council File Number 13-1339)

<u>COMMUNITY/IMPROVEMENT IMPACT STATEMENT</u>: The Greater Valley Glen Council suppports the Code Amendment per Council File Number 13-1339 to add the toyon, the official plant of the City of Los Angeles, and the Mexican Elderberry to the City's list of Protected Trees. Additionally, should there be cause to remove any protected tree, the toyon or Mexican Elderberry shall not be used as substitutions for any other type of protected tree.

W. Hall moved and J. D'Antonio seconded. Motion passed unanimously

- c. Motion for Board approval of a statement supporting passage of Proposition S on the March 7, 2017 ballot. We are concerned that possible large-scale projects in our immediate surroundings will unduly negatively affect both street and freeway traffic and the general ambience of our neighborhoods. The proposition's two-year moratorium on projects seeking General Plan exceptions and spot-zoning; its public review of the General Plan every five years; its requirement that Environmental Impact Reports be conducted independently of the developer/applicant; and its requirement that parking variances be limited will result in future large-scale projects that will better complement the existing cityscape and better recognize and mitigate their effect on existing residents, property owners and businesses.
