- **b.** R. Pisani move and C. Ferreyra seconded expenditure of no more than \$4,500 to Moore Business for website expenses. (\$2900 for website transfer and rebuild, \$800 for montly services for two months, \$400 for training to take place, \$100 for website space expansion and other expenses to be billed, if any.
