Sustainability Report for 11-7-'22 Board Meeting Prepared by Joanne D'Antonio, GVGC Sustainability Representative

Community Forest Advisory Committee (CFAC) 10-6-'22 Zoom

There was a presentation on urban tree management in Barcelona using nature-based solutions to create green corridors and super blocks. The idea of spending millions to treat the city as an ecosystem and removing concrete was questioned there at first, but then the result became very popular with the residents and business owners. Plancheck NC 10-8-'22 Zoom

There were complaints that property owners are piecemealing demolitions with no building plans in place. Also, low-income apartments are being demolished. Vacant lots can sit for years. State law allows non-livable space to be converted to ADUs, and these are being built in parking areas. Reported that demo notices to NCs are only coming from LADBS, but not coming for demos of big projects. There is a Council File regarding a specific plan for the Van Nuys Airport CF 22-1127. In preparation for the Olympics it was reported that \$18 million has been spent on entertainment and travel, and the CEO of the Olympics has a \$999,000 salary. AB 2295 was passed/signed to allow housing of staff on LAUSD sites and waives CEQA to build. AB 2097 was passed/signed that remove any parking minimums on buildings (except medical buildings). SB 1425 was passed/signed requiring cities to have defensible open space for fire prevention. 110 land-related bills are pending!

NCSA Meeting 10-9-'22 Zoom

A new draft of the Wildlife Ordinance has been released. There are concerns that it has been weakened. (Further discussion to take place at NCSA Advocacy Committee meeting)

CFAC Ad Hoc Enforcement Subcommittee 10-13-'22 Zoom

CFAC Chair indicated that the Santa Monica Mountain Conservancy and CLAW have endorsed Hydee Feldstein Soto for City Attorney. There was a discussion of a tree information light pole banner project that could be available to neighborhood councils for sponsorship. The idea of having a tree disclosure and inspection at time of property sale was discussed. DWP is requiring space to replace transformers in front of every new building is causing a loss of street trees and space for trees – this requirement is unique to LA and has created frustration for anyone concerned about the look and health of the city.

Sidewalk Repair Community Advisory Committee 10-27-'22 Zoom

SRP still only able to fix access requests due to their capacity and funding. BOE will make asphalt fixes if reported. Link to put in requests: https://sidewalks.lacity.org/ The program has found ways remove fewer trees as they fix sidewalks. Since the start of the program in 2016, 2,321 sites have been repaired and 133 miles of sidewalk rebuilt.

Community Forest Advisory Committee (CFAC) 11-3-'22 Zoom

Objections to new version of Wildlife Ordinance include exemptions for R1 and RA1 and lack of consideration of protected tree woodlands (maps do exist of these). Objections now can only be made to the Planning Commission by Nov. 17.

Nature-based Solutions and the Dangers of Artificial Turf 11-6-'22 Zoom and in-person Scientists presented studies that the blades on all artificial turf contain PFAS, microplastics for which there is no safe level, and are extremely harmful to athletes and children playing on it, plus it can also leech into water. Artificial turn does not save water since it needs to be watered and utilizes pesticides to abate weeds at the seams!

NCSA Advocacy Committee 11-6-'22 Zoom





Explained that the ecosystem in the hillsides is critical to the health of the entire city, and will create a motion for NCSA Reps to vote on to advocate that the Wildlife Ordinance deal with what is needed for a habitat-driven approach. Fencing has been dropped from ordinance, yet the whole point of wildlife ordinance is to require suitable fencing that allows for wildlife connectivity. There will be a few Olympic events held at the Sepulveda Recreation area. The LA River Project has come up with a plan to upgrade the area with a Central Park-like design that includes better flood management and unpaving the LA River that runs through it to make a kayaking area https://www.theriverproject.org/sepulveda-basin-es . A very different approach from Nury Martinez's plan.
