\$3,861,565 for the term of October 1, 2021 - June 30, 2022 to implement the Council District 4 Encampment to Home Program

Item 9 - \*Motion to push an implementation of the Mello act. Mello act link - <a href="https://ceqanet.opr.ca.gov/2021020124">https://ceqanet.opr.ca.gov/2021020124</a> \*- The GVGC Homelessness Committee moves that the Council direct the Planning Department and Housing and Community investment Department, in consultation with the City Attorney, to prepare and present a permanent ordinance to implement the Mello Act, including a requirement for all new housing developments that are subject to the Mello Act to provide affordable housing.
