We are continuing to send our newsletter out on a regular basis and will put together a call-out for volunteers for the committees and for the board. 6) Update on GVGC one-sheet

Jean put together a one-sheet and asked Carlos for the help with translating to Spanish. It will be presented to the board on Monday for any additional input before we create a new one. Dorothea brought up a discussion we had a brochure previously and will bring it to the meeting to show us. The goal with the one-sheet is to keep the printing costs low by doing a 2-sided flyer.

7) New outreach event ideas for 1st Quarter and 2nd Quarter 2018

- Derek suggested a push to get new members and if that means identifying communities and scheduling a day that we go door-to-door then we could do this to engage the community. We need to work more on the plan on how to coordinate and execute this. We also discussed doing a web, newsletter and social push for members and volunteers. Jean will work on that over the next month since that is something we can do even with the holidays.
- Derek also brought up an idea that we host an event for the dogs of our community and their owners. The idea could be great, we need to put some additional thought into what that looks like and how/when we can do that.
- Dorothea raised the idea that when we host events in the future that we consider adding the additional layer of having a donation of some kind (food, toys, etc.) that we can then donate to a local charity.
