Sample of possible motions for Agenda Item 4 (4a). This motion was submitted to the Chair.

The Greater Valley Glen Council supports a joint project between this council, our Council District (CD 2), the Department of Water and Power, and the Department of Recreation and Parks that would install at the Laurel Grove Park a photovoltaic structure that would provide both power to the electric grid and shade for the park's playground equipment. To this end, the GVGC proposes to encumber \$10,000 of its available funds in support of this project.
