Laurel Grove Park Stakeholders to inquire about Quimby Funds (Peggy Kelly). Laurel Grove Park Stakeholders to clean up area next to embankment on 8-1-15 @ 8AM. SMyrick suggested they contact Outreach Committee to schedule Email blast. CSamson started discussion about the trees we were supposed to get from Beautify LA. SMyrick will press the matter after supplemental watering is scheduled.
  - MJannol started discussion about add'l park benches in the west part of Valley Glen Community Park.
