*The Community Safety Committee recommends the Greater Valley Glen Council purchase one mobile Radar Feedback Device at a cost of no less than \$6,000 and no more than \$7,000, which will allow for flexible placement of such devices, provide real time data to LAPD Valley Traffic Division, and thus enable LAPD to deploy enforcement resources when they see increased speeds in those areas. This purchase would allow the GVGC to respond to constituent complaints of speeding in their neighborhoods, and provide an opportunity to respond to anecdotal evidence with data for perceived problem areas.*
