COMMUNITY SAFETY COMMITTEE MEETING - MINUTES

**PUBLIC INPUT AT NEIGHBORHOOD COUNCIL MEETINGS — While not necessary, the public is requested to fill out a "Speaker Card" to address the Committee on any agenda item before the Committee takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Committee meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer.

- **2.** Roll Call Julie Casey, Thomas Newton, and Sloan Myrick. (Public present: Dianna Rose and Deputy City Attorney Tamar Galatzan)
- 3. Guest Speaker Deputy City Attorney Tamar Galatzan regarding influx of Neighborhood Disputes
 - Tamar has brought to our attention that there has been a huge influx in neighborhood disputes resulting in police calls and law suits. She came to the safety meeting to help us generate ideas on how to reduce the issue because a good portion of the disputes could possibly be handled out of court.
 - Tamar informed the committee that through the City Attorney's Office there is a free Dispute/Resolution service that
 the public has not been utilizing and possibly does not know exists. We will have a booth/table set up at the GVGC
 Summer Festival to educate the public on this service.
 - Safety Committee will work with Tamar to try to reduce escalated neighborhood disputes through:
 - Establishing more Neighborhood Watches. This will help the neighbors meet each other and there will be a block captain to hopefully de-escalate problems between neighbors.
 - Create and distribute a "Good Neighbor Information Sheet" that has a list of applicable laws and a list of city
 departments that manage specific scenarios when applicable instead of calling the police or filing a law suit.
 - After creating the "Good Neighbor Information Sheet", the Safety Committee will distribute it in the VGNA
 May Newsletter, at the GVGC Summer Festival on June 3, GVGC email newsletter, possibly
 Councilmember Krekorian's newsletter, and direct home delivery.
 - Possible Motion
 - MOTION 1: The Safety Committee is requesting the Greater Valley Glen Board approve the
 creation and distribution of a "Good Neighbor Information Sheet" that has a list of applicable good
 neighbor laws, a list of what city departments manage specific scenarios that frequently come up in
 neighbor disputes, and information on the free dispute/resolution service offered by the city
 attorney's office.
 - Vote:3-yes Julie, Sloan, Thomas; 0-no Motion passes.
 - The committee, along with Tamar and Dianna, also discussed how to reduce speeding and traffic accidents in the Greater Valley Glen area. Tamar said we could request a Traffic Senior Lead Officer and DOT to come to a meeting to address the public's concerns. The committee will work on researching this problem and work on finding a solution.

 - Possible Motions
 - MOTION 2: The Safety Committee requests the Board approve allocation up to \$400 to subscribe to Survey Monkey for 1 year to gather data for the Community Safety Survey and for additional Greater Valley Glen surveys as the need arises.
 - Vote:3-yes Julie, Sloan, Thomas; 0-no Motion passes.
 - MOTION 3: The Safety Committee requests the Board approve allocation up to \$3,000 to install 7
 Neighborhood Watch signs in city approved locations (about \$430 per sign installation). Approved monies
 and spending is contingent upon how much is left in the Neighborhood Council's budget for the 2017-2018
 fiscal year.
 - Vote:3-yes Julie, Sloan, Thomas; 0-no Motion passes.
- 5. Items Not On Agenda
 - Approve March 2018 Minutes (Vote: 3-yes Julie, Sloan, Thomas) Approval passed
 - A stakeholder near Hartland Mini Park informed the Safety Committee about a month ago that there was possible
 drug activity on Varna & Hartland. After contacting the current Senior Lead Officer in that area, Officer Mike Perez, he
 said he would make random patrols of the area to observe if there are any suspicious activites.
 - Cheryl Cashman contacted Julie to invite her to a Community Police Advisory Board meeting, which meet on the 2nd Thursday of every month. Julie cannot attend the meeting in May, but Thomas from the committee can go. Julie plans on attending the meeting in June.
