- 3. Approve April 2018 Minutes (Vote: 4-yes Julie, Sloan, Thomas, Dianna) Approval passed
- 4. Finalized Community Safety Survey
 - MOTION 1: The Safety Committee requests the Board approve the Community Safety Survey in its current form to be distributed via Survey Monkey.
 - Julie will bring copies of the finalized survey to the Board to review & approve.
 - Vote:4-yes Julie, Sloan, Thomas, Dianna; 0-no Motion passes.
- 5. Funding Support for the Annual Valley Disaster Preparedness Fair
 - MOTION 2: The Safety Committee requests to allocate a Neighborhood Purposes Grant to Southern
 California Preparedness Foundation for \$850 in support of the 11th Annual Valley Disaster Preparedness
 Fair on Saturday, September 29, 2018 at Northridge Fashion Center.
 - Committee Comments: Can we have a banner and/or booth at the Fair to represent the GVGC? Julie asked the coordinator Bill Hopkins and he said we can have a 10x10' booth.
 - Julie will bring copies of the information describing the Fair to the Board Meeting.
 - Vote:4-yes Julie, Sloan, Thomas, Dianna; 0-no Motion passes.
- 6. General/Miscellaneous Safety Matters
 - Tom Newton brought up the website/app NIXLE, which sends out real time updates from local public safety departments such as the LA Police Department and LA Sheriffs Department. He's noticed that the LA Sheriffs department is very active on updating the public but has not seen enough participation from the LAPD. The safety committee members will sign up on the app and see in each of our areas if there are updates from the LAPD (ex: after hearing a helicopter or multiple police sirens). If the committee feels that the LAPD does not send out many updates, we will contact the Captains for the North Hollywood and Van Nuys Police departments to see if they can participate more frequently.





- Walter Hall brought up the lack of parking enforcement regarding commercial vehicles. He's requesting to pass a
 motion to request that DOT put up more signage where necessary and enforce the restrictions. The safety committee
 agrees.
- MOTION 3: The GVGC Safety committee requests that DOT post signs and enforce the regulations prohibiting parking of commercial vehicles longer than 3 hours on city streets per ordinance number 80.69.2 and 80.69.3.
 - Specific areas that need immediate attention:
 - Freeway 170 overpass at Oxnard St and Laurel Canyon Blvd
 - Victory Blvd on weekends between Coldwater Canyon and Whitsett Ave
 - Vanowen Blvd between Whitsett and Laurel Canyon Blvd
