Excessive Speeding and traffic enforcement efforts - updates from CA State Assembly

Ms. Dochoghlian updated the meeting on status of AB 2121 and next steps for the next legislative session. The committee, Ms. Mkhlian and Capt. Neiman agreed that allowing local municipalities more leeway and authority to set speed limits was needed. Ms. Mkhlian pledged to have more cooperation between Assemblymember Nazarian and their corresponding Sacramento staff with Assemblymember Friedman's office on this issue.

Captain Neiman updated the committee on Councilmember Paul Koretz's purchase of Automated mobile speed radar cameras, which focus on license plates for traffic identification, for his West Valley district, and the committee discussed using funds to purchase one in Councilmember Krekorian's district.

The committee will review if QUIMBY funds may be available to affix a unit to a park, or if other discretionary funding from the current budget may be allocated.

5. Motion: Creation of Ad Hoc Community Benefit Agreement Committee re Homelessness/Tiny Homes Village Alexandria Park

After discussion, GVGC Board President Anthony Bethel created an ad hoc committee to be composed of between 5 and 10 stakeholders knowledgeable about, holding and respecting diverse opinions on, and willing to create positive solutions to Homelessness relating to the Tiny Homes Village project, with no more than 3 GVGC Board members on said ad hoc committee. Said Committee's objective will be to solicit input and make recommendations on the creation of a proposed Community Benefit Agreement regarding the operation of the Tiny Homes Village project. Andrea Schmitt will chair the committee.
