### 4. (Re) Passing of Motion: Neighborhood Purpose Grant

The Community Safety Committee moves that the Greater Valley Glen Council issue a Neighborhood Purpose Grant for up to \$7,000 to the Los Angeles Police Foundation for the purpose of purchasing a Radar Feedback Device.

Motion passed unanimously. There was discussion of AB 2121 and other bills currently moving through CA legislature regarding automated speed enforcement. Ms. Soudani was asked to notify the committee if AB 2121 was scheduled to have a hearing for the transportation committee in coming months.

#### 6. Chandler Bike Path - follow up

Officer Keenan did not have a record of any police reports filed on incidents that have occurred on the bike path between Burbank and Oxnard Boulevards. He informed the committee that citizens can file a customer complaint on Metro's website (QR Code below) and also to file a police report online and it will be forwarded to the Transit Unit. Additional recommendations were to call 911 if the incident had just occurred because LAPD can deploy rapidly to the area.

Case reports are vital and LAPD can send undercover units to the area if incidents are clustered.

The committee will compile updated reporting information and post a 'Did you know?' infographic on how to report metro-related incidents on GVGC social media channels.
