Consistent with the March 6, 2022 Letter of Support for the expansion of Yeshiva Ketana to 324 students sent by GVGC to the Planning Commission, GVGC moves to add to the Letter of Support the following conditions:

1. Yeshiva Ketana to hire a crossing guard during pick up and drop off times to aid in safe crossing across Burbank Blvd at the intersection of Laurel Canyon Blvd from the Adat Ari El campus to the Yeshiva Ketana campus;
2. Yeshiva Ketana to hire a traffic monitor to mitigate illegal u turns;
3. Vehicle drop off and pickup of students be allowed only using the parking lot on Laurel Canyon;
4. Yeshiva Ketana use the triplex only for offices;
5. Yeshiva Ketana install noise canceling mitigation to the north side of the triplex;
6. The green curb on Agnes Ave be painted red;
7. No school activities or routine maintenance be allowed to take place on the property after 10pm, unless there is an emergency condition.
