5-8-'19 Neighborhood Council Sustainability Alliance Trees Committee 12:-00-2:00 p.m. Teleconference

Tree removal issues:

- Neighborhood Councils need more time to weigh in on tree removal requests 3 days not adequate, and dates are confusing. 60 days is a better time frame for NCs – ask DONE to help.
- Need to ask Chief Urban Forester Tim Tyson how many removals applied for but not approved and ask Adel Hagekhalil to make the process more transparent.
- A list of 30 tree removals of 3 or more is on the Bureau of Public Works website awaiting
 hearings with no tree removal notices sent to Neighborhood Councils or CFAC. This was
 called to the attention of UFD but no notices have been sent to us. NCSA will find a way to
 at least put what we know on NCSA tree removal notice site.
- Four large liquidambar trees were removed at the end of April from White Oak medians, with
 plans to remove 25-30 more. Also in Encino, street trees were removed from Califa, Tiara
 and one more street without any notification whatsoever. In a phone conversation Tim
 Tyson said he was busy with the Tree Summit and this got past him.
- The NCSA is proposing to do an NCSA Trees Forum
- NCSA Trees Committee Reps will attend the ReLeaf Retreat on May 31st.
