#### ITEM 1: Eli Lipmen, new BONC President.

Eli Lipmen gave his presentation as new BONC Commissioner President. He was appointed to the Commission by the Mayor 3 years ago and acted as VP. He recently became president, replacing Joy Atkinson.

There are 7 Commissioners across the city that oversee the NC system regarding policy. They have the power to certify and de-certify NCs. If an NC wants to change the structure of their NC Board, the changes must be approved by BONC.

Eli Lipmen stated that he wants to enable NCs to be able to do better jobs and empower other Commissioners to work together in order to get things done. One issue is he believes that every neighborhood needs to have an emergency plan.

BONC has been criticized for having too many ad hoc committees, and he will work to reduce the number and listen to the NCs needs. He plans to have a town hall in the Valley in September.

Glen Bailey questioned him about code of conduct and the consequences that do not exist for board members. Eli seemed to agree with Glen the need to have codes of conduct and possible enforcement but did not have a solid response and claimed that he would work on that.
